Directions to the Peterson home:

Coming via Edens Highway going north, exit at Lake St. West.

Coming on Edens Highway going south, exit at Skokie Rd. and follow that past Edens Plaza Shopping Center to Lake St. (2nd light) and turn right to go west.

Coming from either direction, continue west on Lake St. to Sunset Ridge Rd. (5th light). Turn right (north) onto Sunset Ridge Rd. and drive until you come to Burr Oak Drive West, the last street before the 1st stop sign (Winnetka Ave.).

Once on Burr Oak, you will come to the “pro-verbial fork in the road.”

Go left or right (the two form a circle) and you will come to Dan and Melanie’s home on the east side of the street.

If you miss the left turn onto Burr Oak, go to the stop sign & turn left onto Winnetka Rd and then left onto Mickey Ln. which will lead you to Burr Oak Drive.
